- 6. Discuss and consider a resolution instructing the City Clerk to open a second account in accordance with the newly adopted budget and authorize the City Clerk and Mayor of the City to act as signatories on behalf of the City.
- 7. Receive and consider citizen input on the solid waste / recycling proposals from the September 26, 2015 Community Meeting.
