Notice is hereby given that the City of Sandy Oaks Planning & Zoning Commission (“Commission”) will hold a meeting on Thursday, June 17, 2021 at 6:30 p.m. by telephonic and video conferencing which will be livestreamed and accessible to the public for the purpose of considering the agenda items as provided below.

In accordance with the order of the Office of the Governor issued March 16, 2020 and in an effort to advance the public health goal of limiting face-to-face interactions (also called “social distancing”) to slow the spread of the Coronavirus (COVID-19), the Commission will meet by and provide livestream video and/or telephonic access of the meeting to the public. Up to three (3) persons may register on behalf of the group in order for the spokesperson to be allotted up to nine (9) minutes to speak.
3. Consideration and approval of minutes from May 6, 2021 and June 3rd, 2021 meeting.
4. Workshop to discuss proposed Comprehensive Zoning Ordinance for the City of Sandy Oaks and/or take possible action on the proposed Comprehensive Zoning Ordinance.
5. Discussion and possible action on scheduling the next meeting(s) and/or public hearing(s) of the Commission.
6. Adjourn.
