Notice is hereby given that the City of Sandy Oaks Planning & Zoning Commission (“Commission”) will hold a meeting on Thursday, June 3, 2021, at 6:30 p.m. by telephonic and video conferencing which will be livestreamed and accessible to the public for the purpose of considering the agenda items as provided below.

A recording of the telephonic meeting will be made and will be available to the public in accordance with the Texas Public Information Act upon written request.

Up to three (3) persons may register on behalf of the group in order for the spokesperson to be allotted up to nine (9) minutes to speak.

4. Workshop to discuss proposed Comprehensive Zoning Ordinance for the City of Sandy Oaks and/or take possible action on the proposed Comprehensive Zoning Ordinance.
5. Discussion and possible action on scheduling the next meeting(s) and/or public hearing(s) of the Commission.
6. Adjourn.
