A recording of the telephonic meeting will be made and will be available to the public in accordance with the Texas Public Information Act upon written request.

4. Workshop to discuss proposed Comprehensive Zoning Ordinance for the City of Sandy Oaks and/or take possible action on the proposed Comprehensive Zoning Ordinance.
5. Discussion and possible action on scheduling the next meeting(s) and/or public hearing(s) of the Commission.
6. Adjourn.
