A recording of the telephonic meeting will be made and will be available to the public in accordance with the Texas Public Information Act upon written request.

- 4. Workshop to discuss proposed Comprehensive Zoning Ordinance for the City of Sandy Oaks and/or take possible action on the proposed Comprehensive Zoning Ordinance.
- 5. Discussion and possible action on scheduling the next meeting(s) and/or public hearing(s) of the Commission.
- 6. Adjourn.
