- 6. Workshop to discuss proposed Comprehensive Zoning Ordinance for the City of Sandy Oaks and/or take possible action on the proposed Comprehensive Zoning Ordinance.
- 7. Discussion and possible action on scheduling the next meeting(s) and/or public hearing(s) of the Commission.
