RESOLUTION NO. 2016--41

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANDY OAKS, TEXAS CANVASSING THE ELECTION RESULTS OF THE GENERAL ELECTION HELD ON NOVEMBER 8, 2016 FOR THE PURPOSE OF ELECTING THE MAYOR AND ALDERMEN FOR PLACES 2 AND 4; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Sandy Oaks, Texas (“City”) ordered a General Election for Tuesday, November 8, 2016 for the purpose of electing the Mayor and Aldermen for Places 2 and 4 (“Election”); and

WHEREAS, the returns and accompanying records of the Election have been delivered to the Mayor of the City and are attached hereto as Exhibit A and incorporated hereto by reference; and

WHEREAS, section 67.003(a) of the Texas Election Code provides that except as provided by Subsection (b) or (c), each local canvassing authority shall convene not earlier than the eighth (8th) day or later than the eleventh (11th) day after election day for the purpose of canvassing the election results and in an election described by Section 65.051(a-1) of the Texas Election Code, the time for the local canvass may be set not later than the fourteenth (14th) day after election day; and

WHEREAS, the City Council, after review and examination of the returns and accompanying records of the Election is of the opinion that the reports are in all respects proper and legal; and

WHEREAS, section 67.004(a) of the Texas Election Code provides that only two (2) members of the canvassing authority are needed and constitute a quorum for the purpose of canvassing election results; and

WHEREAS, a quorum of the City Council met on November 17, 2016, to duly canvass the election returns of the Election attached hereto as Exhibit A and incorporated by reference as if fully set forth herein;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SANDY OAKS, TEXAS THAT:

SECTION 1. That the findings set forth above are incorporated into the body of this resolution as if fully set forth herein.

SECTION 2. That the City Council officially finds and determines an election was duly ordered to be held and legally held in the City of Sandy Oaks, Texas on the 8th day of November, 2016 for the purpose of electing the Mayor and Aldermen for Places 2 and 4.

SECTION 3. That the returns attached hereto as Exhibit A are canvassed and approved and that the persons who are listed below with the most votes are declared elected, unless challenged as permitted by law, as Mayor and Aldermen for Places 2 and 4, subject to further qualifications as provided by law:

SECTION 4. That after the canvass of votes by the City Council and completion of election certification, the Mayor shall promptly prepare and issue to the person named with the most votes in Section 3 of this resolution a Certificate of Election, and after filing the required statement disavowing bribery with the City Clerk and taking the required oath of office, the person identified in Section 3 with the most votes shall occupy his or her respective position as a member of the City Council of the City, and is entitled to serve for a term of two years unless otherwise provided by law.


SECTION 5. This Resolution shall become effective immediately upon its passage.
