RESOLUTION NO. 2017-77

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANDY OAKS, TEXAS AUTHORIZING THE CITY CLERK TO SUBMIT EMINENT DOMAIN AUTHORITY REPORT TO THE COMPTROLLER PURSUANT TO GOVERNMENT CODE SECTIONS 2206.151 THROUGH 2206.157, PROVIDING FOR INFORMATION REQUIRED BY THE REPORT, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Government Code Section 2206.154 requires that public and private entities with eminent domain authority submit a report containing records and other information specified by Government Code, Chapter 2206, Subchapter D for the purpose of providing the Comptroller with information to maintain the eminent domain database under Government Code Section 2206.153 in a form and manner prescribed by the Comptroller not later than February 1 of each year; and

WHEREAS, the City of Sandy Oaks, Texas (“City”) is an entity with eminent domain authority as described by Government Code Section 2206.151; and

WHEREAS, the City Council desires to submit a report as required by Government Code Section 2206.154 and authorizes the City Clerk to submit such report on behalf of the City by February 1, 2018 with the assistance of any City personnel, officer or representative, as necessary.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SANDY OAKS, TEXAS:

SECTION 1. The City Council instructs the City Clerk to submit a report containing records and other information specified by Government Code, Chapter 2206, Subchapter D for the purpose of providing the Comptroller with information to maintain the eminent domain database under Government Code Section 2206.153 in a form and manner prescribed by the Comptroller not later than February 1, 2018. The City Clerk may obtain such information required by the report with the assistance of any City personnel, officer or representative, as necessary.

SECTION 2. The report shall contain the following information:


1. The City’s full legal name.
2. The City’s address and public contact information.
3. The name and contact information of the appropriate officer, or other person representing the City.
4. The type of entity.
5. The legal provision(s) granting the City’s eminent domain authority.
6. The focus or scope of the eminent domain authority granted to the City.
7. The earliest date the City had authority to exercise the power of eminent domain.
8. The City’s taxpayer identification number, if any.

9. Whether the City exercised its eminent domain authority in the preceding calendar year by filing a condemnation petition under Section 21.012, Property Code.
10. The City's Internet website address or, if the entity does not operate an Internet website, contact information to enable the public to obtain information from the entity.
11. Any other information required by the Comptroller to comply with Government Code Sections 2206.151 through 2206.157.

SECTION 3. This Resolution shall take effect immediately from and after the passage and approval of this Resolution.
