**ORDINANCE NO. 2019-132**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SANDY OAKS, TEXAS AUTHORIZING A CHANGE OF THE DATE, TIME AND LOCATION OF REGULAR CITY COUNCIL MEETINGS.**

**WHEREAS**, by Ordinance 2018-92 establishes the date, time and place of its regular City Council meetings in accordance with section 22.038 of the Local Government Code; and

**WHEREAS**, the City Council of the City of Sandy Oaks (“City”) finds that two Regular City Council meeting per month are necessary to carry out the business of the City and therefore desires to amend Ordinance No. 2018-92 and replace it with this Ordinance;

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SANDY OAKS, TEXAS:**

**Section 1.** Regular City Council meetings of the City Council of the City of Sandy Oaks shall be held at 6:30 p.m. on the second and fourth Thursdays of each month, unless specially set for another time or date by the Council, or unless the meeting would be in conflict with a City holiday or in other appropriate circumstances. The City Council may hold and/or commence its regular meeting at a time after 6:30 p.m. provided that regularly scheduled meetings will not be held before 6:30 p.m. or commence at an earlier time than provided in the notice of the meeting.

**Section 2.** Meetings of the City Council of the City shall always be open to the general public, with the exception of closed sessions as allowed by law. No vote or action shall be taken except in open session, and, except at a regular meeting or lawfully called special or emergency meeting.

**Section 3.** Meetings of the City Council will be held at City Hall located at 4451 Hickory Haven, Sandy Oaks, Texas 78112, or may be held at an alternate location in the event the Municipal Building is not available or appropriate circumstances provide for an alternate location.


**Section 4.** This Ordinance shall supersede and replace Ordinance No. 2018-92 and all other ordinances and resolutions establishing the date, time and location of regular meetings of the City Council.

**Section 5.** If any section, subsection, sentence, clause or phrase of this Ordinance for any reason is held invalid, illegal, or incapable of being enforced, such section, subsection, sentence, clause or phrase shall be excluded to the extent of such invalidity, illegality, or unenforceability; all other sections, subsections, sentences, clauses or phrases hereof shall remain in full force and effect.

**Section 6.** This Ordinance shall take effect immediately from and after the passage and approval of this Ordinance.
