Notice is hereby given that the City of Sandy Oaks Planning & Zoning Commission (“Commission”) will hold a meeting on Thursday, August 19, 2021 at 6:30 p.m. by telephonic and video conferencing which will be livestreamed and accessible to the public for the purpose of considering the agenda items as provided below.

4. Workshop to discuss proposed Comprehensive Zoning Ordinance for the City of Sandy Oaks and/or take possible action on the proposed Comprehensive Zoning Ordinance.
5. Discussion and possible action on scheduling the next meeting(s) and/or public hearing(s) of the Commission.
6. Adjourn.
