ORDINANCE NO 2022-210

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SANDY OAKS, TEXAS TERMINATING THE MAYOR'S DECLARATION OF LOCAL STATE OF DISASTER DUE TO SEVERE WINTER WEATHER EMERGENCY ISSUED ON FEBRUARY 14, 2021 AND REPEALING ORDINANCE NO. 2021-177.

WHEREAS, on or about February 14, 2021, the Mayor of the City of Sandy Oaks issued a "Declaration of Local State of Disaster Due to Severe Winter Weather Emergency" in accordance with Texas Government Code § 418.108 ("Declaration"), declaring a local state of disaster for the City of Sandy Oaks due to Winter Storm Uri; and

WHEREAS, on or about February 25, 2021, the City Council of the City of Sandy Oaks, Texas adopted Ordinance No. 2021-177 renewing and continuing the Declaration in its entirety and incorporated the Proclamation issued by the Governor of the State of Texas on February 12, 2021, declaring a state of disaster for the State of Texas, and subsequent amendments to that Proclamation, and the Joint City of San Antonio and Bexar County Winter Weather Emergency Declaration issued by the County Judge of Bexar County and the Mayor of San Antonio on February 13, 2021, which declared a local state of disaster caused by the winter weather emergency for the County of Bexar, including all suburban cities, and the City of San Antonio and subsequent amendments to that joint declaration; and

WHEREAS, Ordinance No. 2021-177 provides that any and all ordinances, orders, resolutions, rules, regulations, policies or provisions in conflict with its provisions are temporarily repealed and rescinded to the extent of any conflict therewith until the Local State of Disaster Due to Severe Winter Weather Emergency expires or is lifted; and

WHEREAS, the conditions necessitating the Declaration renewed and continued by Ordinance No. 2021-177 have ceased to exist; and

WHEREAS, the Government Code Chapter 418, the Texas Disaster Act, provides that a local state of disaster may be terminated by the governing body of the political subdivision or by executive order of the Mayor;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SANDY OAKS, TEXAS:

SECTION 1. The City Council, as the governing body of the City of Sandy Oaks, finds any actions relative to the emergency and/or local disaster are no longer necessary and hereby terminates the Declaration as described in the preamble above and repeals Ordinance No. 2021-177.

SECTION 2. Any and all ordinances, orders, resolutions, rules, regulations, policies or provisions in conflict with the provisions of this Ordinance No. 2021-177 which were temporarily

repealed and rescinded to the extent of any conflict with Ordinance No. 2021-177 are declared in full effect.

SECTION 3. Any and all ordinances, orders, resolutions, rules, regulations, policies or provisions in conflict with the provisions of this Ordinance are hereby repealed and rescinded to the extent of any conflict herewith.

SECTION 4. If any section, subsection, clause, phrase or provision of this Ordinance, or the application thereof to any person or circumstance, shall to any extent be held by a court of competent jurisdiction to be invalid, void or unconstitutional, the remaining sections, subsections, clauses, phrases or provisions of this Ordinance, or the application thereof to any person or circumstances, shall remain in full force and effect and shall in no way be affected, impaired or invalidated.

SECTION 5. This Ordinance takes effective immediately after its passage and approval by the City Council of the City of Sandy Oaks and its filing with the City Secretary.
