## **RESOLUTION NO. 2022-169**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANDY OAKS, TEXAS DECLARING CERTAIN PROPERTY AS SURPLUS AND AUTHORIZING THE CITY CLERK, OR HER DESIGNEE, TO DISPOSE OF SAID PROPERTY.

WHEREAS, the City of Sandy Oaks, Texas ("City") established a scholarship program for graduating high school seniors of the City by Resolution No. 2020-113, which was funded by the sale of Fiesta medals, donations, and other sources determined to serve a public purpose; and

**WHEREAS**, the City terminated the scholarship program and repealed Resolution No. 2020-113 by Resolution No. 2022-168; and

**WHEREAS**, the City is the owner of certain items of personal property of Fiesta medals more particularly described herein, which funded the scholarship program; and

WHEREAS, it has been determined that the aforesaid personal property is not needed or required for the City's foreseeable needs but still has some usefulness for the purpose it was originally intended and may or may not have value and therefore determined as surplus property; and

WHEREAS, the City Council desires to authorize the disposal of the personal property by distributing to citizens visiting City Hall and finds this distribution accomplishes a public purpose of promoting a sense of community and civic pride within the community and benefits citizens and the City; and

WHEREAS, the City Council desires to dispose of the surplus property identified and authorizes the City Clerk, or her designee, to dispose of said property as authorized herein;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SANDY OAKS, TEXAS:

**SECTION 1. FINDINGS.** The City Council finds the statements made in the preamble above are true and correct.

**SECTION 2. DECLARATION OF SURPLUS PROPERTY.** The City declares the personal property described as approximately 594 Fiesta medals for the years 2020 and 2021 purchased for the City's scholarship program are not needed or required for the City's foreseeable needs but finds still have some usefulness for the purpose they were originally intended and may or may not have value and therefore declared as surplus property of the City.

**SECTION 3. AUTHORIZATION OF DISPOSAL.** The City Clerk, or her designee, is hereby authorized to dispose of said personal property by distributing the personal property to citizens visiting City Hall to promote a sense of community and civic pride or dispose of the personal property in any other manner in compliance with State law.

**SECTION 4. SEVERABILITY.** If any section, paragraph, sentence, clause, phrase or word of this Resolution or the application thereof to any person or circumstance is held invalid or unconstitutional, such holding shall not affect the validity of the remaining portions of this Resolution, and the City Council hereby declares that it would have passed such portions remaining despite invalidity or unconstitutionality.

**SECTION 5. EFFECTIVE DATE.** This Resolution shall be effective immediately upon its passage.
