- 1. Call to order and quorum call. Mayor Martinez called the meeting to order at 6:32 p.m. In attendance were Mayor Pro Tem Alvarado, Aldermen Coffindaffer and Repino, Alderwoman Martinez, and Interim City Secretary Katherine Yelton. Absent was Alderman Fillinger.
- 2. Pledge of Allegiance. Led by Mayor Martinez.
- 3. Citizens to be heard. Citizens David and Sara Reyes signed up to speak regarding the ongoing problem with dogs throughout the city.
- 4. **Mayor & Administrator Announcements/Updates** Mayor Martinez mentioned the parking lot is under construction for the next few weeks and that Election Day is Tuesday, March 5 from 7:00 a.m. to 7:00 p.m.
- Public Hearing Community Development Block Grant. The City of Sandy Oaks invites all citizens to a public hearing at 6:30 p.m. on February 29, 2024, at the City Hall, 22870 Priest Rd, Sandy Oaks, TX 78112, to discuss and obtain comments regarding a proposed performance statement amendment to its 2021 Texas CDBG Program Community Development Contract CDV21-0020. This amendment is intended to add adjacent work to the current grant agreement. The adjacent work would take place along Lowman in the Hilltop Peaks neighborhood to assist with inadequate street drainage resulting in frequent flooding and unsafe conditions.
