**RESOLUTION NO. 2024-210**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANDY OAKS ADOPTING A POLICY ON MEDICAL AND PSYCHOLOGICAL EXAMINATION OF LICENSEE AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Senate Bill 1445 of the 88<sup>th</sup> Texas Legislature amended the Texas Occupations Code to include section 1701.167 to require the Texas Commission on Law Enforcement (“TCOLE”) to adopt a model policy prescribing standards and procedures for the medical and psychological examination of a license holder or person for whom a license is sought by a law enforcement agency to ensure the license holder or person is able to perform the duties for which the license is required; and

**WHEREAS**, Texas Occupations Code section 1701.167(b) requires each law enforcement agency in Texas to adopt the model policy adopted by TCOLE or a substantively similar policy by September 1, 2024; and

**WHEREAS**, the Sandy Oaks Police Department presents the Medical and Psychological Examination of Licensee, which is the model policy adopted by TCOLE, to the City Council for adoption; and

**WHEREAS**, a law enforcement agency adopting a policy pursuant to the Texas Occupations Code section 1701.167 must submit such policy to TCOLE and TCOLE maintains a copy of the policy;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SANDY OAKS, TEXAS:**

**SECTION 1. PREAMBLES INCORPORATED.** The City Council finds and declares that the facts and recitations set forth in the preamble to this Resolution are true and correct.

**SECTION 2. ADOPTION OF MEDICAL AND PSYCHOLOGICAL EXAMINATION OF LICENSEE POLICY.** The City Council hereby adopts the Medical and Psychological Examination of Licensee policy, which is attached hereto and incorporated herein, for the Sandy Oaks Police Department, and further incorporates such policy into the Policy Manual for the Sandy Oaks Police Department in effect at the time of the passage of this Resolution and as it may be amended from time to time.

**SECTION 3. SUBMISSION BY CHIEF OF POLICE.** The Chief of Police is hereby directed to submit this Resolution and the Medical and Psychological Examination of Licensee policy to TCOLE.

**SECTION 4. REPEALER CLAUSE.** The City Council hereby repeals any part of the Policy Manual of the Sandy Oaks Police Department or personnel policies adopted or approved by

the City Council applicable to licensees or peace officers of the City, that are inconsistent or in conflict herewith, to the extent of such inconsistency or conflict.

**SECTION 5. EFFECTIVE DATE.** This Resolution and adopted policy shall take effect immediately upon its passage.
