Fund balance starting as of May 1, 2024, was at \$328,528.68, checks and payments cleared were \$81,256.24, deposits and other credits \$45,114.71, so the ending balance of the General Fund as of May 31, 2024, was \$292,387.15. The ARPA Fund balance was the same as last month with an ending balance of \$225,207.28 and the TDA Grant Fund balance was the same as last month with the ending balance of \$51,970.00.
