RESOLUTION NO. 2025-230

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANDY OAKS, TEXAS ACKNOWLEDGING RECEIPT OF CERTIFIED APPRAISAL ROLL AND TAX RATE CALCULATION WORKSHEET; AND CONTAINING RELATED PROVISIONS.

WHEREAS, on July 25th, 2025, the Mayor received the certified appraisal roll or certified estimate of taxable value from the Chief Appraiser; and

WHEREAS, pursuant to Texas Tax Code § 26.04(e), the Mayor submitted the certified appraisal roll and tax rate calculation worksheet including the no-new-revenue and voter-approval tax rates to the City Council of the City of Sandy Oaks (the "Taxing Unit") attached hereto and fully incorporated herein; and

WHEREAS, the City Council desires to proceed with the steps necessary to levy ad valorem taxes by acknowledging receipt of the appraisal roll and tax rate calculation worksheet, including the no-new-revenue and voter-approval tax rates;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SANDY OAKS, TEXAS:

SECTION 1. FINDINGS OF FACT. The matters described in the preamble of this resolution are found and determined to be true and correct and are adopted, ratified and confirmed.

SECTION 2. RATIFICATION OF ACTIONS OF ASSESSOR AND COLLECTOR OF TAXES. All actions by the assessor and collector of taxes prior to this date, with respect to such calculations and publications are approved, ratified and confirmed in all respects.

SECTION 3. ACKNOWLEDGEMENT OF RECEIPT OF APPRAISAL ROLL AND TAX RATE CALCULATION WORKSHEET. The City Council hereby acknowledges receipt of the appraisal roll and tax rate calculation worksheet, including the no-new-revenue and voter-approval tax rates, and may proceed with the steps necessary to levy ad valorem taxes.

SECTION 4. REPEAL OF CONFLICTING RESOLUTIONS. All resolutions and parts of resolutions in conflict herewith are hereby repealed to the extent of the conflicts only.

SECTION 5. SEVERABILITY. If any word, phrase, clause, sentence, paragraph, section or other part of this resolution or the application thereof to any person or circumstance, shall ever be held to be invalid or unconstitutional by any court of competent jurisdiction, the reminder of this resolution and the application of such word, phrase, clause, sentence, paragraph, section or other part of this resolution to any other persons or circumstances shall not be affected thereby.

SECTION 6. OPEN MEETINGS. The City Council officially finds, determines and declares that a sufficient written notice of the date, hour, place and subject of each meeting at which this resolution was discussed, considered or acted upon was given in the manner required by the Texas Open Meetings Act, as amended, and that each such meeting has been open to the public as required by law at all times during such discussion, consideration and action. The City Council

ratifies, approves and confirms such notices and the contents and posting thereof.

SECTION 7. EFFECTIVE DATE. This resolution shall take effect immediately upon its approval and adoption.
