RESOLUTION NO. 2025-238

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANDY OAKS, TEXAS VOTING FOR A DIRECTOR TO SERVE ON THE BEXAR APPRAISAL DISTRICT'S BOARD OF DIRECTORS.

WHEREAS, the Bexar Appraisal District's Board of Directors is comprised of nine directors, five of which are appointed by the taxing units that participate in the district in a manner prescribed by Section 6.03 of the Texas Property Tax Code, pursuant to Section 6.0301(c) of the Texas Property Tax Code; and

WHEREAS, in accordance with Texas Property Tax Code Section 6.0301(e), members appointed by the taxing units participating in the district serve staggered four-year terms beginning on January 1 of every other even-numbered year; and

WHEREAS, Section 6.03(k), Texas Property Tax Code, provides the governing body of each taxing unit entitled to vote shall do so by resolution, which must be submitted along with the ballot to the Chief Appraiser before December 15, 2025; and

WHEREAS, Section 6.03 Texas Property Tax Code states that taxing units with at least 5% of the total votes in the appointment of the Bexar Appraisal District Board of Directors must determine its vote by resolution adopted at the first or second open meeting of the governing body held after the date the Chief Appraiser delivers the ballot to the presiding officer of the governing body; and

WHEREAS, the Chief Appraiser delivered the ballot to the Mayor on November 7, 2025 and the second open meeting of the City Council held after the date the Chief Appraiser delivered the ballot to the Mayor is December 11, 2025;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SANDY OAKS, TEXAS THAT:

SECTION 1. FINDINGS. The City Council hereby finds all of the above premises are true and correct and hereby approves and incorporates such findings into the body of this Resolution as if copied in their entirety.


SECTION 2. The City Council hereby votes for Roland Ramirez to serve as director on the Bexar Appraisal District Board of Directors.

SECTION 3. The Mayor or City Clerk is directed to submit this Resolution along with the ballot to the Chief Appraiser not later than the third day following the date the resolution is adopted or before December 15, 2025, whichever is earlier.

SECTION 4. This Resolution shall take effect immediately from and after the passage and approval of this Resolution.


