RESOLUTION 2026-244

A RESOLUTION NAMING A CITY PARK IN HONOR OF ALDERMAN TOM REPINO; RECOGNIZING ALDERMAN REPINO'S CONTRIBUTIONS TO THE CITY OF SANDY OAKS AS AN ALDERMAN AND TO THE CITY PARK; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Tom Repino was a devoted citizen of the City of Sandy Oaks ("City") serving as Alderman for the City from 2017 to 2025 and dedicated much of his life to the United States serving in the United States Army Infantry for 30 years; and

WHEREAS, Alderman Repino passed away on December 6, 2025 while serving in the position of Alderman Place 3 and up until his passing, dedicated his service to the City as an Alderman and member and Chair of various committees of the City, including the Park Advisory Committee, and enhanced the City park, its recreational facilities, and impacted the community in general; and

WHEREAS, the Park Advisory Committee met on January 6, 2026, and recommended naming the City park the "Tom Repino Park" in memory and honor of Alderman Repino; and

WHEREAS, the City Council finds the naming of the park is consistent with the City's *Naming Policy Guidelines for City Buildings, Facilities, Land, or any Portion Thereof* ("Naming Policy") and desires to name the City park located at 4451 Hickory Haven Drive the "Tom Repino Park;" and

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SANDY OAKS, TEXAS THAT:


SECTION 1. NAMING OF TOM REPINO PARK. The City Council hereby names the City park located at 4451 Hickory Haven Drive the "Tom Repino Park" to recognize, honor, and express appreciation to Alderman Tom Repino for his dedication and service to the United States and to the City of Sandy Oaks as an Alderman and a member and Chair of various committees of the City, including the Park Advisory Committee, and for his dedication to enhancing the City park, its recreational facilities, and for his impact to the community in general.

SECTION 2. WAIVER OF PROCEDURES IN NAMING POLICY. Any procedures not complied with by the Council as outlined by the Naming Policy are hereby and effectively waived by three-fourths vote of the City Council upon passage of this Resolution.

SECTION 3. EFFECTIVE DATE. This Resolution shall take effect immediately from and after the passage and approval of this Resolution.


