RESOLUTION NO. 2026-254

A RESOLUTION OF THE CITY OF SANDY OAKS, TEXAS, AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION AND ACCEPTANCE OF FUNDS UPON AWARD IN AN AMOUNT NOT TO EXCEED \$500,000.00 FROM THE U.S. DEPARTMENT OF TRANSPORTATION FOR THE SAFE STREETS AND ROADS FOR ALL (SS4A) PLANNING AND DEMONSTRATION GRANT PROGRAM FOR THE DEVELOPMENT OF A COMPREHENSIVE SAFETY ACTION PLAN; FORMALLY REQUESTING A WAIVER OF THE REQUIRED LOCAL MATCH; COMMITTING A LOCAL MATCH OF \$125,000.00 FROM AVAILABLE FUNDS IF THE WAIVER IS NOT APPROVED; AND DESIGNATING AN AUTHORIZED OFFICIAL.

WHEREAS, the City of Sandy Oaks, Texas (“City”) recognizes the importance of roadway safety and is committed to reducing traffic-related fatalities and serious injuries; and

WHEREAS, the Safe Streets and Roads for All (“SS4A”) Program provides funding for planning and demonstration activities; and

WHEREAS, the City desires to develop a Comprehensive Safety Action Plan to identify high-risk roadway conditions and improve safety; and

WHEREAS, although the program requires a local match of \$125,000.00, the City formally requests a waiver due to limited financial capacity; and

WHEREAS, in the event the waiver is not approved, the City commits to providing the required \$125,000.00 local match from available funds;

WHEREAS, the City Council desires to authorize the submission of grant application and acceptance of funds under the SS4A Planning and Demonstration Grant Program and designate an authorized official;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SANDY OAKS, TEXAS:

SECTION 1. The City Council finds the statements made in the preamble above are true and correct.

SECTION 2. The City Council authorizes the submission of a grant application under the SS4A Planning and Demonstration Grant Program.

SECTION 3. The City Administrator is designated as the Authorized Official to execute all documents to submit the application and effectuate the acceptance of funds upon award.

SECTION 4. The City formally requests a waiver of the \$125,000.00 match, and commits to providing the match if the waiver is denied through allowable sources of an amount not to exceed \$125,000.00 and contingent on the City's Fiscal Year Budget beginning on October 1, 2026 and ending on September 30, 2027.

SECTION 5. The City Administrator is authorized to accept funds upon award of an amount not to exceed \$500,000.00 on behalf of the City for purposes outlined in the grant application and as allowed by the SS4A Planning and Demonstration Grant Program.

SECTION 6. The City commits to completing all required planning and reporting activities.


SECTION 7. This Resolution is effective immediately upon its passage and approval.
